


## **Energy rating and score**

4. Replace single glazed windows with low-E double glazed windows	£3,300 - £6,500	£105
5. Internal or external wall insulation	£4,000 - £14,000	£662
6. Solar photovoltaic panels	£3,500 - £5,500	£421
