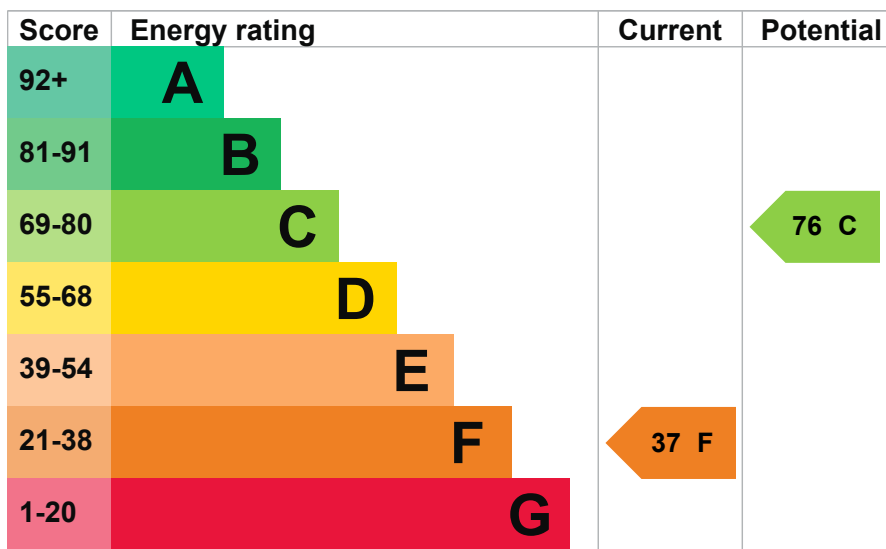

## How this affects your energy bills

An average household would need to spend **£2,956 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills.

## Step 3: High heat retention storage heaters

Potential rating after completing steps 1 to 3 **76 C**
